Bachelor Thesis from the year 2017 in the subject English Language and Literature Studies - Linguistics, grade: 2,0, University of Mannheim, language: English, abstract: In this thesis, the accuracy of the Common European Framework of Reference for Languages (CEFR) is explored with the help of a study investigating the German L2 morphosyntactic competence of 15 English L1 speakers in two settings: a language assessment test setting as well as in online processing. Within this thesis L2 morphosyntactic competence was limited to the two investigated areas of subject-verb-agreement (SVA) as well as the distinctive verb placement in German main and subordinate clauses. Previous research has identified these two linguistic areas as being especially prone to error in adult L2 acquisition of German. Since all test takers varied in their German language proficiency levels (encompassing a range from A2 to B2 according to the CEFR) it was hypothesised that L2 learners of a B2 language proficiency level generally outperform L2 learners of a lower language proficiency level (B1 and A2) in all investigated areas. However, this hypothesis could not be affirmed since the study did not find significant differences in the morphosyntactic competence of English German L2 learners between test takers of distinctive CEF language proficiency levels.

Problems and Suggestions for Teaching." The features of sound in a language are systematically structured. They are divided into two main branches: (a) the branch of segmental features including consonants and vowels, and (b) the branch of supra-segmental features including stress, intonation, pause, juncture, and rhythm (Nasr 1997: 2). My paper refers to branch (a) and illustrates the differences between the English (RP) and German consonant and vowel systems. The resulting contrasts reveal the main difficulties German learners of English are confronted with, therefore, these need to be exposed in teaching (Kufner 1971: 36). After contrasting the sound systems, I will comment on the aim and importance of learning English pronunciation, and then I will explain the error degrees caused by the sound contrasts. Later, there is an overview of the most important qualifications of a phonetic teacher, and finally I will provide suggestions for teaching the pronunciation difficulties caused by the differences between the two languages.

In a broader context, it usually consists of an interwoven system, the so-called Tense-Aspect-Modality (TAM). English and Romanian are no exception. Haase states that "it is far from simple to attribute TAM-categories clearly to either tense, aspect or mood, since most categories contain a temporal as well as an aspectual or modal meaning." (Haase, 1994:135). In order not to go beyond the intended scope of this analysis, I will thus straightforwardly compare English and Romanian past tenses, thereby avoiding a detailed discussion on the inner TAM workings of each language, as this could easily fill entire books on its own. Nonetheless, when absolutely necessary, I will include mood and aspect since both of them cannot be entirely ignored in an analysis about time-related utterances. My main concern, however, is to illustrate the general differences of the tense systems rather than to consider all the exceptions that follow in their wake. Thus, before explaining the construction of the main past tenses, I will provide a short overview and definition of the terms tense, aspect and mood in the English and Romanian language.
