Consequently, the comminution process cannot be continued. Therefore, it is believed that the cryogenic crusher is the most critical component in the cryogenic comminution system. The

research on the temperature increase and energy consumption in the cryogenic crusher is not only to reduce the energy consumption of the crusher, but also to reduce the energy consumption of the cryogenic system.
