Homelessness in America Information Plus
 The last thirty years have witnessed an urban renaissance in America. Major cities have managed to drive down the murder rate, improve the schools, restore the built environment, and revitalize their economies. Middle class families are putting down roots in neighborhoods once given up for dead. But solutions to homelessness have eluded even the most successful cities. While the South Bronx was once synonymous across the globe for "slum," now, San Francisco and Los Angeles are just as internationally

notorious for their homelessness crises. Indeed, the same cities with the worst homelessness crises rank among America's most successful. One of the crisis' more perplexing features is how cities that have met with so much success with respect to economic development, crime and public education have failed to even ease their homelessness crisis, much less end it. In *Homelessness in America*, Stephen Eide examines the history, governmental and private responses, and future prospects of this intractable challenge. The "chronic" nature of the challenge should be understood, he argues, by reference to American history and American ideals. The history of homelessness is bound up with

industrialization and urbanization, the closing of the West, the Great Depression, and the post WWII decline and subsequent revival of great American cities. Though we've used different terms ("tramp" "hobo" "bum") at other times, something like homelessness has always been with us and the debate over causes and solutions has always involved conflicts over fundamental values. After explaining why homelessness persists in America and correcting popular misconceptions about the issue, Eide offers concrete recommendations for how we can do better for the homeless population. *Homelessness in America* engages readers by answering the most common questions their audience brings to the topic and

exploring other questions that are no less important for being not as commonly asked. Homelessness intersects with multiple other policy areas: education, urban development, criminal justice reform, mental health. By exploring the intersection of homelessness with so many other policy areas, this book aspires to provide a comprehensive account of the challenge.

Homelessness in the United States

This volume represents a new theoretical and empirical approach to the study of homelessness. Rather than focusing on the behavioral characteristics and social deviance of the homeless themselves, the incomes, rents, and demographic characteristics of a population of renters who are at risk of homelessness are examined. Based on a study of changes in four U.S. metropolitan areas over an eight year period in the supply of low-cost and affordable housing, Karin Ringheim contends that the extent of homelessness in individual areas is not simply a function of the extent of poverty in those areas. Rather, she argues, the increase in number and change in composition of the homeless population is a direct result of the severity of the housing squeeze.

Chronic homelessness is a highly complex social problem of national importance. The problem has elicited a variety of societal and public policy responses over the years, concomitant with fluctuations in the economy and changes in the demographics of and attitudes toward poor and disenfranchised citizens. In recent decades, federal agencies, nonprofit organizations, and the philanthropic community have worked hard to develop and implement programs to solve the challenges of homelessness, and progress has been made. However, much more remains to be done.

Importantly, the results of various efforts, and especially the efforts to reduce homelessness among veterans in recent years, have shown that the problem of homelessness can be successfully addressed. Although a number of programs have been developed to meet the needs of persons experiencing homelessness, this report focuses on one particular type of intervention: permanent supportive housing (PSH). Permanent Supportive Housing focuses on the impact of PSH on health care outcomes and its cost-effectiveness. The report also addresses policy and program barriers that affect the ability to bring the PSH and other housing models to scale to address

housing and health care needs.

Homeless in America Praeger

There have always been homeless people in the United States, but their plight has only recently stirred widespread public reaction and concern. Part of this new recognition stems from the problem's prevalence: the number of homeless individuals, while hard to pin down exactly, is rising. In light of this, Congress asked the Institute of Medicine to find out whether existing health care programs were ignoring the homeless or delivering care to them inefficiently. This book is the report prepared by a committee of experts who examined these problems through visits to city slums and impoverished rural areas, and through an analysis of papers written by leading scholars in the field.

Gregg Colburn and Clayton Page Aldern seek to explain the substantial regional variation in rates of homelessness in cities across the United States. In a departure from many analytical approaches, Colburn and Aldern shift their focus from the individual experiencing homelessness to the metropolitan area. Using accessible statistical analysis, they test a range of conventional beliefs about what drives the prevalence of homelessness in a given city—including mental illness, drug use, poverty, weather, generosity of public assistance, and low-income mobility—and find that none explain the regional variation observed across the country. Instead, housing market conditions, such as the cost and availability of rental housing, offer a far more convincing account. With rigor and clarity, *Homelessness Is a Housing Problem* explores U.S. cities' diverse experiences with housing precarity and offers policy solutions for unique regional contexts. Housing the Homeless The Urban Institute Drawing on a nationally representative sample of interviews with homeless people who use services and with service providers in several large cities, the authors explore the efforts of various states and localities to provide emergency services to homeless people, to help them get out of homelessness, and to prevent homelessness. They find that services and programs to help people work their way out of their homelessness and to prevent homelessness are not well developed, and that the level of interest in finding solutions and the levels of funding to create these solutions vary greatly from state to state.

Diversity Within the Homeless Population Bloomsbury Publishing USA

This is the second of Momeni's two-volume series on homelessness in the United States. While volume I concentrated on the statewide distribution, variations, trends, and characteristics of the homeless population, the present volume addresses the problem of data collection and specific causes and issues that relate to homelessness. Unique in its attempt to bring systematic data and analysis to bear on the subject, this groundbreaking study focuses upon such critical areas as drug abuse among the homeless, the housing situation that gives rise to homelessness, homeless children, food sources, and problems of employment. Although the contributors approach the topic from a number of different perspectives, they are united in their conclusion that realistic solutions to the problem of homelessness rest not in establishing new and dramatic programs, but rather in forging links

between government and private agencies to create a system-wide response to the multiple needs of the homeless population. In addition to exploring the serious and persistent problems homeless people face, the contributors highlight the difficulties inherent in measuring the extent of homelessness accurately, concluding that efforts to do so are likely to produce an undercount. A number of chapters provide a clearer picture of the homeless population in America by examining both the socioeconomic and demographic correlates and the social-psychiatric dimensions of homelessness. Finally, the contributors compare and contrast the characteristics of homelessness and the methods of dealing with the problem in the United States, Canada, and Great Britain. Two concluding essays provide an overview of homelessness on the national level and propose public policies likely to be most effective in reducing homelessness. Numerous tables and figures illustrate points made in the text. Students of social sciences, social practitioners, and public policymakers will find *Homelessness in America* provocative reading, and a reliable source of data and analysis.

The editors of this book draw upon professionals in seven industrialized nations to examine the prevalence, causes, trends, demographics, and health concerns of homelessness and to evaluate potential solutions. They also report on the resources available to the homeless by the public and private sectors in each of the seven countries studied; the United States, Germany, the Czech Republic, Denmark, England, Russia, and Spain. Also provided is a comparison of social welfare systems in industrialized nations with perhaps the most current and accurate statistics regarding Russia available in the literature. The two East European countries, the Czech Republic and the Russian Federation, represent the most radical changes, from a state to a free market economy with their social systems turned upside down. While the former socialist governments provided a system of universalistic care and control, the released uncontrolled free market forces have been eroding most social protection for the individual. Consequently, homelessness as a new phenomena affects those who are not able to compete in the free market economy. The editors tie the data and country-specific chapters together with a series of concluding chapters that include discussions of resources to prevent homelessness, financial resources for the unemployed,

social welfare benefits for the indigent, access to health care and sickness benefits, affordable housing and housing policies, and public and private resources for the homeless.

The concept of homelessness is difficult to define and measure. Generally, persons are thought to be homeless if they have no permanent residence and seek security, rest, and protection from the elements. The homeless typically live in areas that are not designed to be shelters (e.g., parks, bus terminals, under bridges, in cars), occupy structures without permission (e.g., squatters), or are provided emergency shelter by a public or private agency. Some definitions of homelessness include persons living on a short-term basis in single-room-occupancy hotels or motels, or temporarily residing in social or health-service facilities without a permanent address. *Housing the Homeless* is a collection of case studies that bring together a variety of perspectives to help develop a clear understanding of the homelessness problem. The editors include information on the background and politics of the problem and descriptions of the current homeless population. The book concludes with a resource section, which highlights governmental policies and programs established to deal with the problem of homelessness.
