Economic globalization has made national economies susceptible to unpredictable and rapid short-term capital inflows and

outflows. This phenomenon, called Hot Money, is the major subject of the paper. The paper focuses on the development of a theoretical model pertinent to the phenomenon. Chapter 1 provides an overview of the topic and the motivation behind the investigation. In Chapter 2, we review the existent literature regarding Hot Money and continue further to review the literature related specifically to the model. Chapter 3 focuses in the effects of financial liberalization on developing countries including the risks and proven benefits.
