Bombs and Bombings is the definitive text regarding the construction of bombs and the motivation for bombings in the U.S. Although some law enforcement-sensitive material is excluded from this book, it still presents a thorough understanding of why bombs and bombings remain a constant threat. The chemistry of explosives and how such affects the performance of explosives are an essential part of the text. The reader is taken through a short course on explosive engineering and the chemistry of explosives. A brief history of bombings provides insight as to how improvised explosive devices were used to shape history and how the situations of the early 1900s are repeating themselves today. While many believe that suicide bombings are something seen only in the Middle East, this text explores the suicide bombings in the U.S. and the motivation of the bombers. Various profiles of several famous bombers such as the Unabomber and the Mad Bomber are reviewed along with other psychological issues that might inspire bombers. The use of bombs to disperse radioactive materials in the radiation dispersion device configuration is addressed along with the technique used to disperse chemical and biological agents with explosives. Booby traps, especially those targeting law enforcement, are explained, and methods to detect booby traps are developed to allow a rudimentary understanding of the process. Methods to identify clandestine laboratories manufacturing explosives or other drugs such as methamphetamine are identified providing the reader with an understanding of the items to identify and differentiate the types of laboratories. Numerous bombings are examined providing an insight as to why and how the attacks were successful. Mitigation techniques such as using alcohol resistant aqueous film-forming foam to suppress blast and fragment formation are explained along with deployment methods. The text is richly illustrated with photographs depicting IEDs, explosives, and booby traps to assist in the identification of suspicious objects, suspect packages, or potential mail bombs. The book provides an overview that those involved in law enforcement, security, and counterterrorism will find elucidating and beneficial in bomb-related operations and mitigation efforts.

Everyday problems associated with the consequences of alcohol use disorders require answers, and it is for this reason Forensic Alcohol Test Evidence (FATE) was written. Forensic alcohol test evidence focuses on the evaluation, interpretation and application of the effects of alcohol or an alcohol test result to some legal issue such as a crime, accident or consequence of alcohol exposure. In FATE, many of the issues pertinent to a thorough forensic evaluation and trial testimony are discussed, but most importantly is the focus on consistent, unbiased, and comprehensive application of diverse scientific disciplines and research to questions of forensic interest. This requires evaluating behavioral, analytical, physiological, pharmacological and toxicological evidence in the puzzle; determining if the pieces go together; and reaching a conclusion to a reasonable degree of scientific certainty. The first chapter discusses what is forensic alcohol test evidence and why it is studied. Chapter 2 explores forensic alcohol evidence and what are the types of alcohol and quantitative expression of blood alcohol. Chapter 3 examines alcohol pharmacokinetics, alcohol pharmacodynamics site of alcohol action, and basic neurophysiology. Neuropharmacology of alcohol intoxication is also discussed. Chapter 4 covers laboratory and clinical-based tests of impairment. In Chapter 5, DWI high-risk behaviors and injuries are discussed. Chapter 6 defines alcohol and the law: drunk driving, visible intoxication, and aggression, while Chapter 7 covers the DWI investigation and arrest, elements of the DWI report, outside vehicle test, and obtaining blood samples. Chapters 8 and 9 describe alcohol-drug interactions and medical consequences and toxicological considerations. Chapters 10 and 11 pursue alcohol use, tolerance, dependence, and the need for standardization and estimating blood alcohol levels. The remaining two chapters cover accident reconstruction and neuropsychology. This book will be an essential tool and valuable resource for all law enforcement officers and investigators, forensic examiners and other professionals in the evaluation and interpretation of alcohol evidence in crimes and accidents.

**Hearings Before the Subcommittee to Investigate the Administration of the Internal Security Act and Other Internal Security Laws of ..., 94-1** CRC Press

When President Harry Truman authorized the use of atomic weapons against Japan, he did so to end a bloody war that would have been bloodier still had the planned invasion of Japan proved necessary. Revisionists claim that Truman's real interest was a power play with the Soviet Union and that the Japanese would have surrendered even earlier had the retention of their imperial system been assured. Truman wanted the war to continue, they insist, in order to show off America's powerful new weapon. This anthology exposes revisionist fallacies about Truman's motives, the cost of an invasion, and the question of Japan's surrender. Essays by prominent military and diplomatic historians reveal the hollowness of revisionist claims, exposing the degree to which these agenda-driven scholars have manipulated the historical record to support their contentions. And although casualty estimates for an invasion vary considerably, the more authoritative approximations point to the very bloodbath that Truman sought to avoid. Volume editor Robert Maddox first examines the writings of revisionist Gar Alperovitz to expose the unscholarly methods Alperovitz employed to support his claims, then distinguished Japanese historian Sadao Asada reveals how difficult it was for his country's peace faction to prevail even after the bombs had been dropped. Other contributors point to continuing Japanese military buildups, analyze the revisionists' low casualty estimates for an invasion, reveal manipulations of the Strategic Bombing Survey of 1946, and show how even the exhibit commemorating the fiftieth anniversary of the bombing at the Smithsonian National Air and Space Museum hewed to the revisionist line. The Second World War put an end to America's historical isolation from international power politics, and so also to the long-standing American defiance of the Realist ideology that shaped Old World affairs. The advent of transoceanic military technologies, now wielded by menacing states such as Nazi Germany and the Soviet Union, made Americans more receptive to the Realist idea that international relations is about fear and survival. The American Realists Reinhold Niebuhr, Hans Morgenthau, and Kenneth Waltz developed a modern strategic framework that sought to introduce American leaders and the educated public to these harsher realities of international politics.
