That distinction is often challenging and not infrequently requires considerable experience at the bedside. It is not surprising that accurate cytogenetic diagnosis is also often a challenge,

Given the realization that modern human cytogenetics is just over five decades old, it is noteworthy that thorough documentation of normal chromosome variation has not yet been accomplished.
